

HOW TO PLACE A BID ON LUXURYHOMES.BID

Transaction Fee

The Winning Bidder will be responsible to pay a Transaction Fee in addition to the purchase price of the property. The Transaction Fee % is stated on the property profile page. If the Winning Bidder submitted a bid during the Indicative Bid Period then the Transaction Fee may be reduced. For the amount of the Winning Bid equal to the last Indicative Bid by the Winning Bidder (if any), the lower Transaction Fee % stated on the property profile page shall be used.

Example 1: Indicative Bid \$0, final bid in Last Call \$1,000,000.
Transaction fee shall be 6% of \$1,000,000 (\$60,000)

Example 2: Indicative Bid \$600,000, final bid in Last Call \$1,000,000.
Transaction fee shall be 3% of \$600,000 plus 6% of \$400,000 (\$42,000)

Example 3: Indicative Bid \$1,000,000, final bid in Last Call \$1,000,000.
Transaction fee shall be 3% of \$1,000,000 (\$30,000)



Bid Deposit
